



## 2022 SCHOOL BOARD CANDIDATE SURVEY

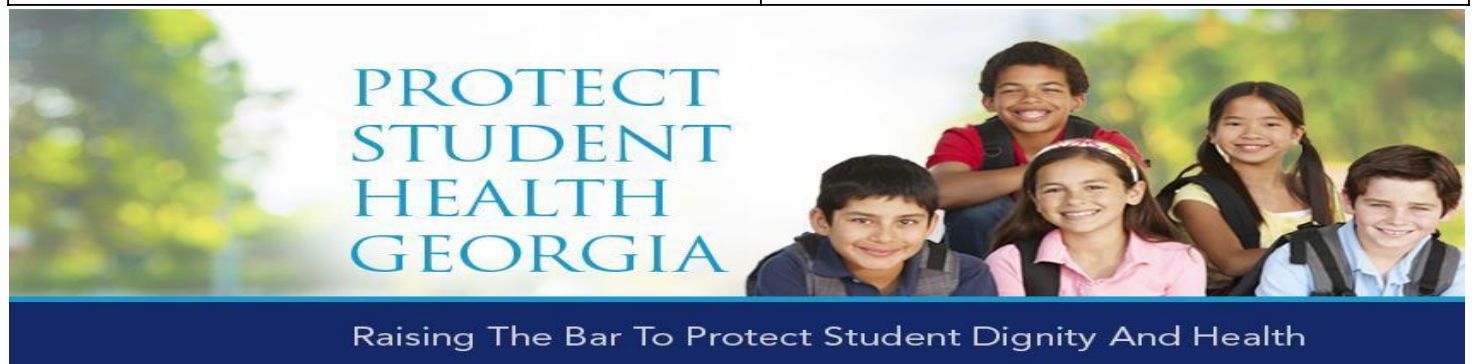
